AUDIT EXECUTIVE SUMMARY:

PCI Strathmore is a citrus packing house that is approx. 115,000 square feet. Oranges and Grapefruit were observed at the time of the inspection. Product is brought to the facility in bins and placed in the degreening rooms (seasonally ethylene gassed), when they are ready and needed for production they are brought to the bin dump area. Bins are submerged and product is flumed (treated with chlorine), sized, pregrade, high pressure washed (recirculated water treated with chlorine), soak tank (recirculated water treated with chlorine), single pass rinse, grading, fungicide flooder (recirculated water treated with PAA), drying with blower, air dried with fans, sorting, dark room, water elimination, wax application, heated dryer, grading by hand or electronic sizing, mechanical and hand pack into cases or bags, palletized and then placed in the cold storage until needed for shipments. Municipality water is used by the operation. There are no allergens handled by the operation and no CCPs identified by the operation.
