AUDIT EXECUTIVE SUMMARY:

PCI Rayo is a citrus packing house that is approx. 135,000 square feet. Lemons were observed at the time of the inspection. Product is brought to the facility in bins and placed in the degreening rooms, when they are ready and needed for production they are brought to the bin dump stations. They are dumped onto the line and ran through optional single pass spray bar that is treated with chlorine, then to the high pressure washer with SBC and treated with chlorine, fresh water rinsed, dark room where rots are removed by hand when needed, air pass, electronically graded, fungicide flooder recirculated treated with PAA, water elimination over brushes and fans, waxing, air dry, heated dryer, hand graded and mechanical packers into cases or mesh or plastic bags into RPCs, Palletized and shipped. Product that is ran on the separate lemon line is binned after the waxing step and stored until needed for production. There are no allergens handled by the operation and no CCPs identified by the operation.
