Exeter Specialties conventional citrus packing house. Product is brought to the packing house in bulk bins, product is dumped onto the conveyor belt, pre-graded and rot removal by hand, ran through the high pressure washer, treated with chlorine, single pass rinse, water elimination/air dryer, wax applicator, heated drying and grading by hand, electronic sizing, and packing, product is palletized, and stored in cold storage until needed for shipment. There are no CCPs identified by the operation and no allergens handles by the operation. After the rinse step is an optional fungicide flooder recirculated water system treated with PAA. This was not in operation at the time of the inspection and has not been run by the operation since April 2024. It is used based on need for fruit quality.
